Dear Ms. Lam:

I write to follow up on our prior discussion and to provide you with an update regarding the status of the National Archives and Records Administration ("NARA") facility located on Adelphia Road, in College Park, Maryland, regarding its use of ground water and its own wastewater treatment system associated with its cooling system and its NPDES Permit No. MD0065871/State Discharge Permit No. 09-DP-2904 ("Permit"). As explained during our prior call, NARA then intended to stop using ground water for its cooling system at this facility, which would eliminate any discharges under its Permit. Since that call, I have been informed that NARA has in fact received approval from the Washington Sanitary and Sewer Commission ("WSSC") to utilize WSSC water and WSSC's sewer return system regarding its cooling system, and as of April 1, 2016, NARA has switched over to this WSSC system. Accordingly, NARA no longer requires its Permit and recently has withdrawn its application to renew that Permit. Attached is a letter from NARA to the Maryland Department of the Environment ("MDE") documenting that NARA switched to the WSSC system as of April 1, 2016, and notifying MDE of NARA's withdrawal of its Permit renewal application. I will notify you once this has been confirmed by MDE.
