Dear Judge Cook and Examiner Moore:

On October 9, 2019 ConocoPhillips Company filed a hearing request with the Railroad Commission for the purpose of obtaining two-year flaring authority for its facilities that are the subject of the 41 dockets shown on the attached list. Since that time ConocoPhillips has instituted operational changes that have significantly reduced the need for flaring at the facilities in response to disruptions of the offtake capacity provided by midstream companies. As a result, the two-year flaring authority sought in these cases is no longer needed. Accordingly, ConocoPhillips hereby withdraws the referenced applications and requests the dockets be dismissed. Docket Nos. OG-20-00002131, OG-20-00002141, OG-20-00002142, OG-20-00002143 and OG-20-00003529 have been set for prehearing conference on September 28, 2020 and a hearing on the merits on October 28, 2020. ConocoPhillips requests those proceedings be cancelled.


