65 Carbon Capture Projects Proposed in Louisiana, Most in U.S.

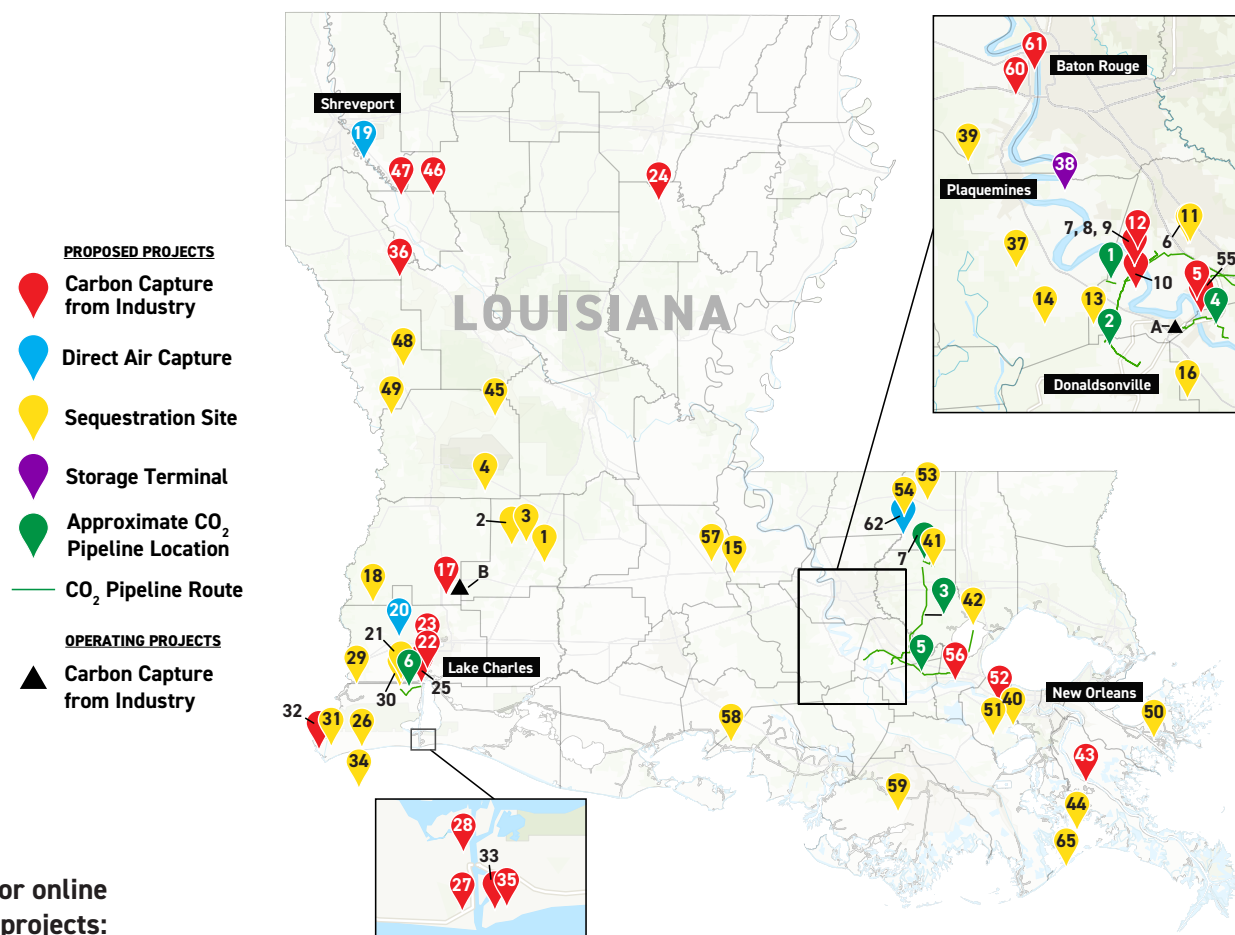

Carbon capture and sequestration (CCS) has been touted by the fossil fuel industry and its allies as a way to address greenhouse gas pollution. But it is an untested technology with risks that, so far, has been mostly used to provide taxpayer subsidies to the oil and gas industry. Since federal tax credits for the practice were increased in 2022, a flurry of CCS projects were announced across the United States, especially in the Gulf Coast region. Three years later, only two carbon capture projects have begun operating in Louisiana and only one has received authorization to geologically sequester carbon dioxide.

The Environmental Integrity Project is tracking CCS projects related to the oil, gas, and petrochemical industries. As of January 2026, at least 65 CCS projects

have been proposed in Louisiana, most of any state. These include 30 projects that propose to capture at least 33 million metric tons of carbon dioxide annually from industrial sites or from the air; 35 facilities that propose to inject at least 135 million metric tons of CO₂ into underground reservoirs; and one CO₂ storage terminal. There are also 11 proposed carbon dioxide pipelines.

About a third (11) of the projects would capture carbon dioxide emissions from ammonia and hydrogen manufacturing facilities. Six would capture these pollutants from liquefied natural gas terminals. And nine would capture emissions from natural gas processing plants or renewable fuel refineries.

UIC permits refer to Underground Injection Control permits authorizing carbon dioxide injection (specifically, Class II or Class VI permits). Not every project needs both types of permits. For example, projects only involving carbon capture will only need an air permit authorizing the construction of carbon capture equipment.
